The Forest Inventory/GIS Analyst will support MB&Gs efforts to manage inventory data, conduct inventory and biometrics analysis, conduct spatial analysis related to inventory data collection, conduct periodic spatial analysis/updates, conduct growth and yield modeling, and perform other tasks related to forest inventory and planning efforts.

- Assists and leads periodic updates of tabular and spatial forest inventory data.
- Assists in the design of timber cruises to meet information needs and satisfy time and cost constraints.
- Assists and leads generation of growth and yield projections.
- Leads the preparation of reports summarizing and comparing results.
- Leads the construction, maintenance, analysis, modeling, and visualization of GIS databases.
- Leads the preparation and edits on geospatial maps and graphic products.
- Supports MB&G's efforts to develop new clients and to expand services to existing clients.

- Manages time to meet objectives of multiple concurrent projects.
- Lead/manage small projects.
- Operates independently under minimal supervision.
