ABOUT THE POSITION

As a Forester / Field Project Manager, you will support MB&G's inventory data collection project, provide assistance with management oversight of a large-scale inventory data collection project, and be responsible for check cruising up to 20 or more cruisers. Ideally, the position will be based in Moscow, ID, but this is flexible upon request; locations such as Orofino, Lewiston, or St. Maries, ID would also be considered. This is a temporary position from approximately March 1, 2017 – October 31, 2017. This position will require overnight travel throughout Northern Idaho on a weekly basis. In this role, you will perform the following:

ESSENTIAL FUNCTIONS/MAJOR RESPONSIBILITIES:

- Conduct check cruising or cruise plot audits during the duration of the project.
- Process check cruise data.
- Interact with cruising contractors on a weekly basis.
- Review check cruise results with the Project Manager and cruising contractors.
- Prepare weekly reports summarizing check cruise results.
- Assist in the design and review of field data collection protocols.
- Assist with various tasks as assigned to ensure successful project completion.
- Work directly with the Project Manager on project specifications and progress tracking.
- Actively promote MB&G as a premier provider of natural resources consulting services.
- Perform other duties as necessary.

- Work is performed primarily in the field.
