Contract administration duties focus on monitoring contractor harvesting, and road construction and maintenance activities.

The West District is a 8 (eight) person team focused on meeting and exceeding client forest management expectations.

### Job Functions and Responsibilities:

- Forestry operations: harvest area reconnaissance, silvicultural prescription development, road reconnaissance and plan development, other land management activities.
- Contract administration of timber harvesting, road construction and maintenance activities.
- Employ established protocols for the development of plans, implementation of timber harvest and road construction projects, and other associated duties.
- Provide field administration of timber product preparation to market specifications.
- Assist in development and administering budgets.
- Participate in forest inventory projects individually or with a team.
- Supervise contracted services, including certifying completion of work for payment.

- Highly proficient with MS Word, Excel, and GIS software.
- Ability to use GPS and hand-held data recorders.
- Potential travel and ability to function as a team member on large projects throughout the U.S.

- Valid driver's license.
- Office and remote field environments. Utilization of various means of transportation including off road and all-terrain vehicles (ATVs) and snowmobiles. Required to drive, ride or walk through rough terrain in difficult weather conditions, in daylight and dark, in wet and dry environments.
