- Oversee the Company's herbicide purchase program
- Represent the Company in cooperative reforestation associations
- Develop and maintain good relationships with Federal and State agencies, local officials, private organizations, and neighboring landowners while representing the interests of the Company and ensuring compliance with applicable laws and regulations
- Recruit new reforestation talent through participation in the Company's intern program
- Cooperate with the Tree Improvement Manager in the construction and operation of the Gazelle tree seedling Nursery
- Coordinate area-wide cone collection activities
